

“GSPD” RULES

1. This competition will be governed by these terms and conditions (the **“Terms”**) and customers agree that they have read and understood these Terms and will be bound by them. **EMBERGEP Korlátolt Felelősségű Társaság** (seat: Hungary, 8230 Balatonfüred, Köztársaság út 19/D 1/1 (the **“Promoter”**) is solely responsible for the execution of this competition.
2. Customers (natural persons, legal persons, unincorporated business association) may enter the competition who have bought the game from the www.spaceworkgame.com site, included those Customers, who have bought the game before the Competition Period.
3. Every purchase has its own Unique ID. During the draw one unique ID will be selected randomly, and the Winner (s) is (are), who has the selected unique ID.
4. This competition is open to customers of the following listed countries only:

9. Each Winner will be notified by e-mail within five (5) business days. The Prize will be posted within 2-4 weeks. The Winner(s) is (are) responsible for providing the Promoter with accurate and up to date contact details and the Promoter will not be liable for any inability to make contact with any Customers due to errors, omissions or inaccuracies in the contact details provided by the Customers.
10. During the Competition Period winner can win only one prize.

11. Customers can not reclaim the price of the game was purchased during the Competition Period.
12. According to the Hungarian law the Promoter will be responsible for the payment of taxes and charges in respect of the Prize. The Promoter is responsible for all cost (postage, customs duties) concerning with the receipt of the prize.
13. The winner(s) is (are) responsible for expenses and arrangements not specifically included in the prizes.
14. After providing the Prize there is no responsibility of the Promoters towards the Prize objection in any way.

All customers hereby irrevocably and unconditionally waive in favor of the Promoter and their assigns and successors in title, all moral rights in any element set out in this clause 17 to which he or she is, or may at any time in the future be, entitled.
18. The Promoter's decision is final with respect to any aspect of the competition, including, without limitation, the determination of each Winner. No correspondence will be entered into with regard to any of Promoter's decisions.
19. The Prizes are as stated and are non-transferable. No cash alternatives will be offered. If due to circumstances beyond the Promoter's control, the Promoter is unable to provide the stated Prizes or any part of them, the Promoter reserves the right to award substitute prizes of equal or greater value. Each Prize is subject to the additional terms and conditions of the supplier.

The Promoter shall not be held liable for any delay in performing or partial or total failure to perform any of their obligations to each Winner under these Terms if such delay or failure is caused by circumstances beyond the reasonable control of the Promoter, including without limitation delays, changes, disruptions, cancellations, diversions or substitutions howsoever caused including without limitation as a result of war, terrorist action or threatened terrorist action, strikes, hostilities, civil commotions, accidents, fire, flood or natural catastrophes or arising without limitation out of or in connection with the activities of third party event organizers and providing the Prize.
21. Each provision excluding or limiting liability is to be construed separately and will apply and survive even if for any reason any of the other provisions are held to be inapplicable or unenforceable in any circumstances. Each of the provisions excluding or limiting liability will remain in force notwithstanding any termination of these Terms.
22. Any personal information, including without limitation, the customer's name, age, address (including postcode), telephone number and/or email address will be used solely in connection with this competition and for any purpose for which the customer specifically opts in and will not be disclosed to any third party except for any purpose for which the customer specifically opts in, and (c) for the purposes of satisfying its obligations pursuant to clause 24 above. Any personal information held by the Promoter in respect of any competition will be held on record for a reasonable period to fulfill the purpose for which such personal information was collected. If an customer gives the Promoter permission to pass on his/her personal information to a third party via a specific express consent/opt-in mechanism, then the privacy policy of such third party handling the personal information shall apply and the handling of the customer's information by such third party shall no longer be the responsibility of the Promoter. Customers have a right to access, correct and have their personal data deleted from Promoter's database. 23. These Terms may be amended or varied at any time by the Promoter on notice.
24. These Terms shall be governed by and construed in accordance with the laws of Hungary. The software used for the automatic draw is documented and verified by APEH (Hungarian Tax and Financial Control Administration) regulations. The results of the draw, and the log files of the full process can be requested and checked till 5 years after the draw by the APEH.
